Format: RDP Tournaments are "round robin" with rotating partners based on numbers drawn at check-in. Winner determined by total points after 15 rounds of play. Ties are broken by total Wins followed by W-L point differential. No refs-USAPA/IFP rules to be followed. USAPA approved Dura Fast 40 outdoor balls provided.

RELEASE, PERMISSION, AND INDEMNITY AGREEMENT

Release & Waiver: As a participant in the "Pickleball in the Park" Tournament (hereafter "Tournament"), I, for myself, my heirs or assigns, **release from liability and waive any claims** against the New Richmond Pickleball Association and its members, City of New Richmond, New Richmond Chamber of Commerce, and any other persons, organizations or entities associated in any way with this Tournament, that may arise from personal injuries, accidents, illnesses, death, and/or property damage or loss related to my participation in the Tournament.
