Release, Permission, and Indemnity Agreement

Waiver. Indemnification and Hold Harmless. I also agree to indemnify and hold harmless Everything Pickleball or Center Court from any and all claims, actions, suits, costs, expenses, damages and liabilities, including attorney's fees brought as a result of my involvement in the Tournament.
