### Release, Permission, & Indemnity Agreement

**Waiver.** In consideration of being permitted to participate in any way in the Spring Fling Scramble ("The Tournament"), I, for myself, my heirs or assigns, do hereby release, waive, discharge and agree not to sue Everything Pickleball, Center Court, The Tournament and its/their officers, employees and agents from liability from any and all claims resulting in personal injuries, accidents or illnesses (including death) and property loss arising from my participation in the Tournament.

**Assumption of Risk.** Participation in the Tournament carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. I have read the previous paragraphs and I know, understand and appreciate these and other risks that are inherent in playing pickleball. I assert that my participation is voluntary and that I knowingly assume all such risks.

**Indemnification and Hold Harmless.** I also agree to indemnify and hold harmless Everything Pickleball or Center Court from any and all claims, actions, suits, costs, expenses, damages and liabilities, including attorney's fees brought as a result of my involvement in the Tournament.
